## Annual Membership Rates | Due on or before March 1st of any calendar year.

**Please note:** If you are a new member, your dues are pro-rated from the time of admission, which takes place at the quarterly general meetings in March, June, September and December. This means that dues paid for March admission are 100% of the total rate owing in your category, but those for June admission are 75% of the rate; those for September admission are 50% of the rate and those for December admission are 25% of the rate. Please make your cheques out for the amount that fits your admission date.
